- ◆ May become a political party precinct delegate
- ◆ May decide the outcome of an election

Who Can Vote?

- ◆ U.S. Citizens, 18 years of age and
- ◆ Have proof of residency:
- ◆ Current Driver's license *or*
- ◆ Approved ID and current utility bill *or*
- ◆ Approved ID and someone in precinct to vouch for you.

- ◆ Voters may vote by absentee ballot in person at the Washington County Government Center or by mail.
