LWV WBLA PROGRAMS

NOVEMBER: YOUTH CIVIC ENGAGMENT

November 9th was a night at the movies! LWV members from the White Bear Lake area, together with a few guests from the Roseville LWV, gathered at Century College to hear from Century College and White Bear Lake students about their work



this fall on voter services. The work and the meeting were funded as part of a grant to our League from Ramsey County Elections, coordinated by Heidi Boyd, chair, Voter Services.



We heard from Catherine Gnali, Century College student senate president, who described the process used to develop questions for videos about the importance of voting and the get out the vote event for Century students at which they were featured along with other information about how and where to vote. Jordan Henderson, the videographer, commented that in creating the videos he wanted to be sure that they related to his generation, that they told personal and real stories, were motivational, and were natural, shot locally. In fact, listening to the students he

filmed he commented was an "eye-opener" for him – motivating him to vote! Because some of the students are not eligible to vote because of their status, Jason realized it would be selfish of him if he didn't vote when so many cannot.

The five videos, each one-two minutes in length, ask the questions: should you vote; how do you know where and how to vote; why should you care about voting; what's your experience with voting, and why should you vote. Wonser Mongrue and Khushi Bakhta, White Bear Lake students, described their participation in the project and their thoughts about voting. Both participated in meetings with Century students; Wonser is one of the students in the videos, and Khushi held three voter registration events at the high school. Because of some staffing changes, they were unable to make a presentation and show the videos to the school's Student Equity Committee before election day when the project ended.

Suggestions from all the students: more education on the positions that are up for election (i.e., what is the role of the mayor, what are the responsibilities of school board members); reach students at an even younger age to remove apprehension about voting; education that even if you can't vote (because of age or status) there are things you can do; education on issues, the "why" to vote; remember the message that "if I want change then I must vote".

Rebecca Thoman is very committed to educating people in our League and community about the Minnesota End-of-Life Options Act. Currently there are 10 states that have enacted similar legislation. The LWV Utah conducted a study on Death with Dignity. The LWV Minneapolis concurred with its position and asked delegates at the LWVMN convention in June of 2021 to concur. The required 3/5 vote was not achieved; it failed by 2 votes. One of the main comments was that people were not educated on what is in the proposed bill.

Please join us for a very informative presentation about the upcoming legislation on the Minnesota Endof-Life Option Act. It was introduced in the House (<u>HF1358</u>) and Senate (<u>SF1352</u>) on February 22, 2021. It is modeled after Oregon's Death with Dignity Act. The legislation would authorize medical aid in dying which allows terminally ill adults of sound mind to request and receive prescription medication they may self-administer for a peaceful death. Learn more about the proposal and bring your questions.

Youth Civic Engagement Fellows Program

Following our work with students from Century College and White Bear Lake (see article on page 2), in 2022 we will partner with the LWV Minnesota on the Youth Civic Engagement Program, an initiative of the Shumer Family Fund and the LWV MN to "integrate a space for youth voices throughout the voter process, while engaging youth in meaningful civic engagement work." LWV WBLA received a grant of \$1,000 for our involvement. This will provide \$250 each to three White Bear Lake High School students and \$250 for reimbursement of any direct costs. With the assistance of League members, the students will design youth registration and get out the vote activities, participate in several training webinars sponsored by the state League, and attend several WBLA meetings. Karen Suzukamo, Lori Soukop, Mary Ellen Kasak-Saxler, and Jackie Reis have volunteered to serve as advisors to the students.

Guest column

2020 was the year that changed everything.

This time last year, election administrators everywhere were exhaling after the scramble to count absentee ballots, keep voters and themselves safe during a pandemic, and prepare for endless unknowns. A year later, our election system is even stronger, having passed that difficult test.

In the November election, Minnesota voters cast their ballots in over 180 local contests across the state. The people spoke on important issues like the funding of school and municipal projects, governance structures for local leaders, and how to make meaningful changes in public safety.

Minnesotans know that local elections make a big difference in daily life, so it's no surprise that we stepped up in every corner of the state to make our voices heard. It's that level of involvement and participation that's the hallmark of our elections.

Minnesota's historically outstanding voter turnout—currently number one in the nation for the past three election cycles—is evidence that our people believe in voting, and believe in the power to make change at the ballot box.

Despite this abiding confidence in our democracy, disinformation about elections persists from a noisy few. These false tales of rigged elections are designed to have a corrosive effect on our democracy. The people actively spreading them seem intent on diminishing trust in the institution of free and fair elections.

And the dangers of allowing disinformation to run rampant is clear: confidence will wane, fear and doubt will rise, and people could ultimately lose out on their most basic rights in our democracy.

As we look forward to the next statewide election, in 2022, it's critically important that everyone has trustworthy information about how to participate and how the system works.

And that's the mission of our office: to be that trusted source so every eligible voter can contribute to the voice of the people.

I played quartets yesterday with a violinist from Roseville who plays in the Northeast Orchestra, and guess what I learned! It originated 27 years ago with LWV members! I am constantly amazed by the rippling influences of LWV! This is from their Facebook page:

The Northeast Orchestra grew from the love of classical music that led 6 members of the **Fridley League** of Women Voters to in 1972 to meet together in one another's homes to play the instruments that they had laid aside years earlier. Almost immediately the group outgrew living rooms and became an orchestra. In the early years the Orchestra used "Chamber" in its name to indicate a small orchestra, but today that description no longer fits - some 60 players play regularly.



The American Flag as a Cultural Symbol

Historian Marc Clague of the University of Michigan launches the dialogue about the American flag with his work on our national anthem. In this panel discussion, Professor Clague will lead us into a consideration of the various emblems of U.S. patriotism—most importantly, the stars and bars of our flag—and what role it plays in defining national identity and staking out political ideologies. Long a symbol of devotion, and of hatred, both nationally and abroad, the United States flag and its attendant artifacts of American patriotism serve as a touchstone to reflect on American identity and the current moment.

Voter Access and Agency and Election Security

While some states race to restrict early/absentee voting, voting-by-mail, and voting by convicted felons, others strive to make polling places more accessible to people with disabilities, and to expand same-day voting registration. How much was the 2020 election a catalyst for these actions? What are the historical trends and factors that have brought us to the present moment? What does evidence tell us about various forms of voting access and the prevalence of election fraud? These, and other questions, will inform a lively panel discussion about the fundamental right and responsibility of living in a functioning democracy.

Unpacking the Middle

April 7, 2022 @ 3:30-5:00 pm

Despite consistent and widespread interest in third-party politics, recent, record-low ratings for the U.S. Congress, and the ever-widening political chasm between the left and the right, America remains as firmly ensconced in the two-party system as ever. Often left out of the political fray are the voices, experiences, and aims of the so-called moderate middle. Who comprises this group? How do they influence American politics at levels from local to national? And what does the future portend for the role of the middle in healing our divide and possibly escaping the persistent oversimplifications that a binary system presents to U.S. voters? Politicians and academics join the conversation sparked by these timely questions.
